

Currently, 53.9% of the 44,918 housing units in the area are owner occupied; 36.0%, renter occupied; and 10.1% are vacant. Currently, in the U.S., 55.7% of the housing units in the area are owner occupied; 32.8% are renter occupied; and 11.6% are vacant. In 2010, there were 42,536 housing units in the area - 57.7% owner occupied, 33.1% renter occupied, and 9.2% vacant. The annual rate of change in housing units since 2010 is 2.45%. Median home value in the area is \$160,882, compared to a median home value of \$200,006 for the U.S. In five years, median value is projected to change by 3.30% annually to \$189,270.
