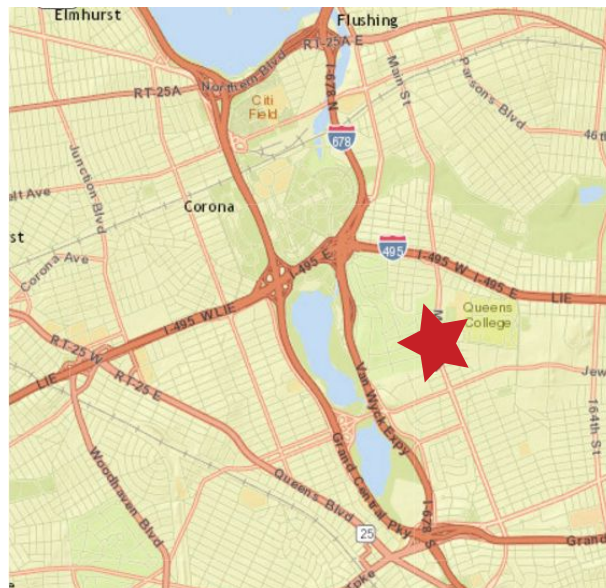

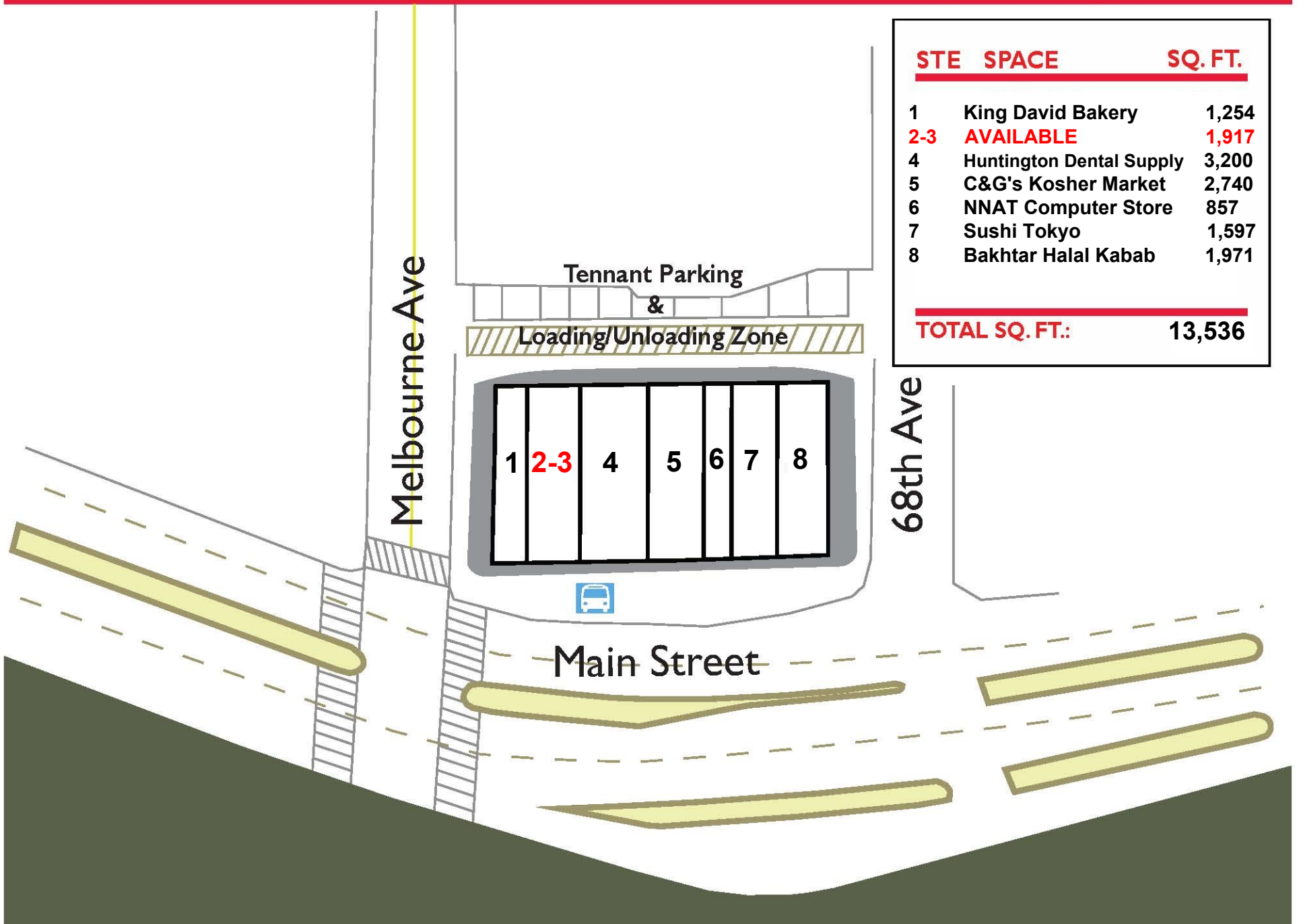

Currently, 39.9% of the 75,072 housing units in the area are owner occupied; 55.2%, renter occupied; and 4.9% are vacant. Currently, in the U.S., 55.7% of the housing units in the area are owner occupied; 32.8% are renter occupied; and 11.6% are vacant. In 2010, there were 73,755 housing units in the area - 40.7% owner occupied, 53.8% renter occupied, and 5.5% vacant. The annual rate of change in housing units since 2010 is 0.79%. Median home value in the area is \$445,544, compared to a median home value of \$200,006 for the U.S. In five years, median value is projected to change by 4.87% annually to \$565,126.
